DISTRICT USE LICENSE AGREEMENT

When you take possession of the **Personality Academy Four Temperaments Quiz (Licensed Product)** you are agreeing to the terms of this Use License Agreement (ULA). This ULA is a binding agreement between the school district or other multi-site organization assigned the license and Personality Academy. By downloading, printing, or otherwise using the Licensed Product, you agree to be bound by the terms of this ULA and agree to use the Licensed Product within ULA guidelines.

This ULA grants you the following rights:

1. **YOU MAY:** Distribute the PDF file of the Licensed Product to all teachers, instructors, or facilitators in your school district or multi-site organization so they may present to students, teachers, support staff, parents, or other participants. The Licensed Product must be used in its unaltered format. Copyright on all pages must remain intact.

Provide instructors with a copy of this ULA and ensure that they understand their rights.

The instructors of your organization are considered assigned license holders and the following statements apply to them.

1. **YOU MAY:** Print and distribute hardcopies of the Licensed Product to all students or participants you instruct for their individual use. You may also distribute printed copies of the handouts to your family, friends, and co-workers for their individual use. Copyright & website on all pages must remain intact.

2. **YOU MAY:** Email the PDF documents of the Licensed Product directly to your students or participants for their individual use. You may allow private downloads from an intranet or other password protected webpage.

3. **YOU MAY:** Email the PDF documents of the Licensed Product to client organizations that you present for so that they may print and distribute hardcopies to the participants *for your workshop only*. Copyright & website on all pages must be kept intact. They are not allowed to publicly post the material in any form on the internet, redistribute it, or use it for workshops or events when you are not present.

It is your responsibility to ensure that your clients understand their rights and that this is copyrighted material that MUST NOT be publicly posted in any form for any reason on the internet or other outlet.

When you email them the handouts, include a written note such as the following:

“Attached are the PDF documents for my upcoming presentation. You have permission to print these handouts for my workshop only. These handouts are licensed to me under a Use Agreement which is not transferable. You do not have permission to redistribute or use these PDF documents for events when I am not present. These handouts **MUST NOT** be posted publicly for any reason.”

The intent is to allow instructors who are assigned license holders to present for other school districts or organizations. If this other school or organization desires to conduct their own training sessions using the Licensed Product, they must acquire their own Use License from Personality Academy.

This ULA requires that you abide by the following use restrictions:

1. **YOU MAY NOT** share your Rights with another party. These Rights are for assigned license holders only. You may not transfer your group rights to the Licensed Product to other school districts or organizations.

2. **YOU MAY NOT** post the Licensed Product publicly.

You must not post the contents of the Licensed Product anywhere for any purpose. This includes but is not limited to blogs, websites, or social sites such as Facebook, Twitter, Instagram, etc. You **MAY NOT** post ANY of content of the Licensed Product on any unsecured personal cloud servers such as but not limited to Google Drive, Amazon S3, Dropbox, etc. where others could access and download.

3. **YOU MAY NOT** print and distribute hardcopies of the Licensed Product.

4. **YOU MAY NOT** resell, distribute, or in any other way use the contents of the Licensed Product other than to support instruction that you personally deliver live either in-person or virtually. You must contact Personality Academy for written permission prior to any use in pre-recorded instruction or instruction that will be broadcast publicly.

5. **YOU MAY NOT** include the contents of the Licensed Product in any other publication (for fee or no fee). The contents of the Licensed Product **MAY NOT** be inserted, excerpted, segmented, **or modified in any way** for use in any derivative product or offering without prior authorization from Personality Academy.
